

# PARSEC PRIZE

ESTABLISHED 2005

One of the fundamental values at Parsec Financial is giving back to the communities in which we serve. We have long maintained a significant commitment to charitable giving and this core value is why we established the Parsec Prize in 2005.

The Parsec Prize is designed to help local non-profits further their missions and help improve the lives of those served in our communities. Since 2005, Parsec has awarded more than \$1.7 million in Parsec Prize grants to 93 local non-profits. The Parsec Prize represents approximately one-half of Parsec's annual charitable giving.

Grants are made to non-profit organizations that are certified tax-exempt under section 501(c) (3) of the U.S. Internal Revenue Service code. Though they may be commendable organizations, in order to keep our charitable giving more focused, the following are ineligible for application to the Parsec Prize:

- Endowments or capital campaigns
- Fundraising activities, such as benefits, charitable dinners, galas or sporting events
- Goodwill advertising, souvenir journals or dinner programs
- Individual needs, including scholarships, sponsorships and other forms of financial aid and assistance
- Political causes, candidates, organizations or campaigns
- Religious organizations
- Sports sponsorships
- Travel for individuals or groups

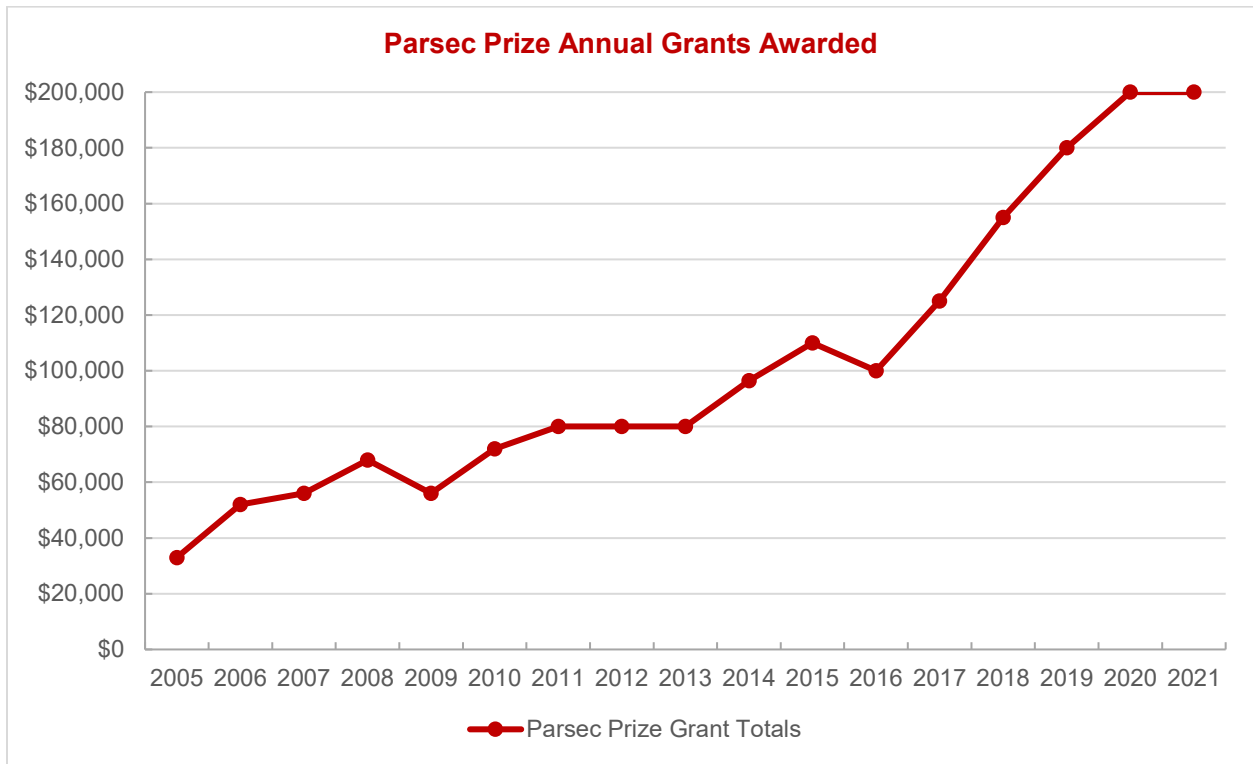
